New Business

1. <u>CITY OF GIG HARBOR PUBLIC WORKS DEPARTMENT, GIG HARBOR, WA 98335:</u>

Austin Estuary Park Honoring Project, (PL-SDP-21-0004, PL-DR-21-0172, PL-FLOOD-21-0002 & PL-SPA-21-0008). The proposal is to install a public art project honoring the first peoples at this location. The piece is titled "Our fisherman, Our guardian". The artwork which is proposed to be mounted to a concrete base and will consist of a carved house post not exceeding 18-feet in combined height. The concrete base will be cast-in-place, 4-feet wide, and may contain up to four (4) placards or signs attached to the base. The structure will be located in the upland area approximately 15-feet from the high tide line of Gig Harbor Bay. The

structure will not be illuminated and will be carved of wood with a muted palette. The artwork will have a neutral and natural appearance, with a finish to protect it from the elements. A 5-foot wide gravel path will surround the public art piece to facilitate the public's access to the carving. Areas temporarily disturbed for structure installation will be revegetated after installation is complete. The applicant proposes mitigation and monitoring measures to ensure no net loss of ecological function associated with Gig Harbor Bay and the two (2) Category II estuarine wetlands whose buffers the piece is proposed to be installed within.

2. WALT & NORA SMITH, Gig Harbor, WA 98335: Smith Rezone, (PL-REZ-21-0001 & PL-SEPA-21-0007) Pursuant to the provisions contained within the Development Agreement executed between the property owner and the city of Gig Harbor on November 28th, 2016 and recorded under AFN 201612060071, the owner is requesting approval to rezone three parcels to R-2. Section 9 of said agreement allows the property owner to request rezone approval within 5 years of the effective date of the associated Comprehensive Plan Land-use Amendment designating the subject site Residential Medium.
