- Provide proof of FCC and other regulatory approvals required to provide the service(s) or utilize the technologies sought to be installed.
- Provide construction drawings which depict all existing and proposed improvements related to the proposed location, including but not limited to: poles, driveways, ADA ramps, equipment cabinets, street trees and structures within 250 feet. The construction drawings shall also include the applicant's plan for electric and fiber utilities, all conduits, cables, wires, handholes, junctions, meters, disconnect switches and any other ancillary equipment or construction necessary to construct the small wireless facility.

Applicant may be asked to provide a traffic control plans well as those elements that are typically contained in the right-of-way use permit to allow the applicant to proceed with the buildout of the small wireless facility deployment.

The City of Gig Harbor reserves the right to ask additional questions on a case-by-case basis.
